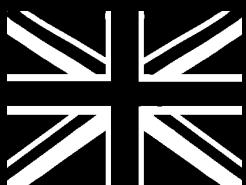

AGREEMENT

- Nicolet Area Technical College (hereafter NATC) and the course instructors give notice that all arrangements are made by them as agents upon the express condition that they shall not be responsible for any injury, damage, loss, accident, delay or irregularity which may be occasioned either by reason of any defect in any vehicle, or through the acts or default of any company or person engaged in conveying the passenger, or in carrying out the arrangements of the study tour, or otherwise in connection therewith, nor do they accept responsibility for losses or additional expenses due to delays or other changes in means of transportation, or other services, sickness, weather, strikes, or other causes.
- The right is reserved to make such alterations, deletions, additions, or modifications in the itinerary and academic program as may be found necessary or desirable by the course instructors. NATC reserves the right to withdraw its sponsorship of and offer of academic credit for the tour due to a lack of 15 paying participants or due to the unavailability of a qualified member of the faculty to act as the course instructor. If NATC withdraws its sponsorship, the college shall not be responsible for cancellation fees imposed upon those tour participants who then determine to cancel their reservation.
- NATC, course instructor, and agents of NATC will not be acting in a supervisory capacity during the study tour, and, accordingly, do not accept responsibility for the activities or safety of study tour participants. In addition, NATC shall bear no responsibility for medical expenses resulting from illness, injury, or accident which occurs during the study tour.
- I assume full legal and financial responsibility for my participation in the study tour.
- I will adhere to the payment schedule as outlined above. If, for any reason, I should leave the study tour before its completion, I will not be entitled to any refund of payment.
- I grant NATC, its employees, agents and representatives the authority to act in any attempt to safeguard and preserve my health or safety during my participation in the program including authorizing medical treatment on my behalf and at my expense and returning me to the United States at my own expense for medical treatment or in case of an emergency.
- I agree to conform to all applicable policies, rules, regulations and standards of conduct as established by NATC, any sponsoring institution and/or foreign affiliates, as well as tour requirements, to insure the best, harmony, comfort and welfare of the tour.
- I accept termination of my participation in the study tour by NATC with no refund of fees and accept responsibility for transportation costs home if I fail to maintain acceptable standards of conduct as established by NATC and/or foreign affiliates.
- I agree not to deviate from the established itinerary of the study tour except in case of legitimate emergency and then only with the consent of the course instructor.
- I agree to voluntarily and without reservation to indemnify and hold harmless NATC, the NATC District Board and their respective officers, employees, and agents from any and all liability, loss, damages, costs, or expenses (including attorney's fees) which do not arise out of the negligent acts or omission of an officer, employee, and agent of NATC and NATC District Board while acting within the scope of their employment or agency, as a result of my participation in the program, including any travel incident thereto.
