- I understand that I must follow Nicolet College policies and procedures, as outlined in the College catalog under Student Rights and Responsibilities and by the course instructor, including course withdrawal and attendance policies.
- I realize that Nicolet College classes are college-level. I will respect my instructors and fellow classmates by attending class, and being an active, informed, and involved college student.
- I agree that it is my responsibility to ensure completion of any courses necessary for fulfillment of my high school graduation requirements.
- I understand that it is my responsibility to request any necessary educational accommodations through Nicolet College's Support Services Department.
- I am willing to spend 2-4 hours on homework per hour that the class is in session. (For example: Your class meets 3 hours/week-plan on around 6-8 hours of homework/week).
- I realize that homework is due on the day the instructor says it is due. Late homework will result in a lower grade or even a "0".
- I understand that I must attend every class period to which I am assigned. If I must miss a class I must have a legitimate and excusable reason, I will contact my Nicolet College instructor prior to my absence and be prepared to make up any missed work.
- I realize that courses have very strict attendance policies and I may be asked to drop a course if I miss too many class periods or receive a failing grade if I do not drop the course.
- I realize that all courses (for example: Nursing Assistant) require me to meet competencies before moving on to the next. If I can not meet competencies I will be asked to drop the course or receive a failing grade for the course if I do not drop the course.
- I realize that if I do not pass and/or drop the College course(s), my high school may hold me responsible for tuition and book fees.
- I understand that it is my responsibility to drop myself from the course either online or by filling out an add/drop form, which can be found at the Welcome Center in the Red Oak Center.
- I understand that the high school will only be refunded 100% of the tuition for my course if I drop on or before the 1st day of class. Anything after that will result in a reduced tuition refund to my high school and my high school may hold me responsible for this tuition amount.
- I will keep in frequent contact with my high school counselor. I will check with my high school counselor before dropping a course.
- I realize that I am responsible for attending class at Nicolet College even if my high school is not in session that day.
- I will seek help from my instructor immediately when needed in order to be successful in the course.
- I am aware that Dual Enrollment is a privilege. My high school believes in me enough to financially support this opportunity for me. I have read through, understand, and will follow the requirements listed above.
