ADDED TO THE SECOND SENTENCE OF THE FOURTH PARAGRAPH TO READ "THE REVIEW WILL UPDATE THE BOARD ON MARKET CONDITIONS, BUDGET ENVIRONMENT, AND PRACTICES RELATED TO COMPENSATION." MOTION CARRIED UNANIMOUSLY ON A VOICE VOTE.
